Raising the bar, the theme of this year's conference, recognises the vital role which managers play in driving performance and managing change across the health services. Dr. James Reilly, T.D.

Dr. James Reilly, T.D. was appointed Minister for Health in 2010. Previously he was Party Spokesperson for Health from 2007 and he became Deputy Leader in 2010. He worked as a G.P in North County Dublin for 25 years. Dr. Reilly is a past President of the IMO. He served on the Eastern Health Board, the Eastern Health Authority and the Northern Health Board.



Stuart Bain

Stuart has held a number of top level appointments including Chief Executive of NHS National Services Scotland (NSS), and Interim Chief Executive of NHS Education for Scotland (NES). Previously, he worked with Redbridge Health Authority which he joined in 1986 and held a number of senior management and Board level positions within that authority. He was Chief Executive of Redbridge Healthcare when it achieved NHS Trust status. Stuart was President of the Institute of Healthcare Management from 2007 to 2011.



Dr. Tracey Cooper

Tracey's previous role was as Deputy Head and Director of Operations for the National Health Service Clinical Governance Support Team in the United Kingdom. Her previous experience includes working clinically in emergency medicine, emergency care services and health system reform. Tracey has worked in, and advised on, a variety of different health systems in different regions. Tracey is currently the President for the International Society for Quality in Health Care.



Dermot Goode

Dermot is the leading advisor on health insurance in Ireland and has extensive knowledge of the Irish health insurance industry having worked in senior management and consultancy roles with organisations such as VHI; Irish Pensions Trust; Mercer; and BUPA Ireland. In 2011, his healthcare business was acquired by Cormarket Group Financial Services. He advises the media on healthcare developments in the market and is a regular contributor to health insurance discussions on both radio and television.

Prof. John Higgins

John has been an important contributor to health service reform and change management both regionally and at national level. He was previously Chair Reconfiguration Forum, South. Trained in Internal Medicine in TCD, he later established an international reputation in Obstetrics and Gynaecology as a practitioner and researcher in Australia before returning to take UCC Chair in Obstetrics & Gynaecology in 2001. He is strongly committed to the integration of the delivery of clinical care with the teaching, training, research and innovation agendas.



Dr. Peter Lachman

Leads the transformation programme in Great Ormond Street Hospital. Peter trained as a paediatrician in Capetown. He worked with several prominent healthcare organisations there before joining the NHS, where he has held a number of top level positions. His move to Great Ormond Street Hospital and the Royal Free Hospital in 2005, coincided with taking up a Health Foundation Improvement Fellowship at the Institute of Healthcare Improvement in Cambridge, Massachusetts. He has worked on change management programmes in Ireland, Sweden and the US.



Dr. Ambrose McLoughlin, BDS, MBA

Ambrose was appointed in April 2012, he has over 30 years' experience as a practitioner, policy maker and within the management structures of the health services in Ireland. In recent years, he has been a leading advocate for and contributor to a number of major change programmes. His previous posts include; Registrar/Chief Executive of the Pharmaceutical Society of Ireland (PSI), the pharmacy regulator; CEO North Eastern Health Board (NEHB) and Deputy CEO NEHB, responsible for Acute Hospitals and Community Services.



Tony O'Brien

Tony has worked in Ireland since 1991. Previous posts include Chief Executive Officer of both the UK and Irish Family Planning Associations, Director of BreastCheck, Chief Executive Officer of the National Cancer Screening Service and Associate and Interim Director of the National Cancer Control Programme. In 2011 he was appointed as Chief Operating Officer of the Special Delivery Unit and also became a member of the Department's Management Advisory Committee (MAC).
